Pride and Promote Hosts and manages the official LGBT Beach & Unity Celebration Recognized by the State of California, the County and the City of Los Angeles. Pride and Promote is known for it's annual Beach Pride Event AT THE BEACH™ (ATB).



## REGISTRATION & PAYMENT REQUIREMENT

1. **Insurance and License:** All vendors must provide license & insurance coverage.
2. **Product Liability Insurance:** Your insurance policy binder must include the following words: (**Insurance Certificate that indemnifies Pride and Promote Pride and Promote Los Angeles Black Pride**)
3. **Non-Profit vendors:** A copy of IRS nonprofit status must be provided with the application form
4. **Merchandising Vendors:** Provide a copy of your state of California seller's permit with your application if you will Be selling any items
5. **Cleanliness:** Festival grounds clean up. The vendor is responsible for cleaning up in and around their booth space before leaving event. Your booth and surrounding area will be inspected regularly to ensure you meet with this requirement, you will be asked to vacate premise and forfeit all payment if you fail to oblige with these and all other requirement. There is a dumpster provided for vendor's disposal trash. Bring your own container to store used cooking oil, **do not dump used oil or trash on event grounds!!** The area will be monitored for cleanliness.
6. **Fire Safety:** Food vendors are required to have a minimum of pound ABC fire extinguisher in their booth.
7. **Electricity:** Vendors requiring electricity must furnish counter-tops backdrops, extension cords (12-2 with ground 100' maximum)
8. **Vendor Space Usage:** we only offer a 10X10 booth space with a table and two chairs At The Beach™ event. At the host hotel we only offer a table and two chairs. No vendor will be allowed to keep any items outside their booth area. If you feel more space is needed, please purchase additional booth(s). Additional booth is granted only if available.
9. **Payment: NO CASH OR PERSONAL CHECKS ACCEPTED.** Cashier Checks or Money Orders only, must be paid in full and sent 30 days before the beginning of the festival.
  - a. Your payment is due by May 29, 2024, you may be penalized if payment is sent after due date. Proof of sent payment date is considered by the postal date or the electronic payment date.
  - b. Vendors not paid in full will not be allowed to set up and will forfeit their down payment,
  - c. We cannot guarantee a vending space if your payment is not received by the due date. We also accept electronic Payments
  - d. All checks must be sent to "PRIDE AND PROMOTE"

## PRELIMINARY VENDOR AGREEMENT

1. Vendors requesting prime location, corner booths or same location as previous year will only be considered for such if all fees are paid in full by deadline. No partial payments accepted
2. There will be **NO SHARING** of booth space. Only one business is to be named on the contract and only that business will be allowed to operate in that given booth space
3. Purchase of booth space is in the form of 10ft x 10ft parcels if you need additional space for your display racks or tables there is an additional fee equal to the amount of an additional booth and it must be purchased in advance. No tables, display racks or any other display of merchandise shall protrude any further than 12 inches from any 10'x10' booth space
4. Any violation of the above mentioned or unwillingness to cooperate with festival staff regarding complaints or violations will be cause for removal from the festival grounds with all payments being forfeited by vendor
